OFFSHORE CANCELLATION POLICY AND GENERAL PROCEDURES FOR M/V FLING & SPREE

Full payment is required to reserve your place on the M/V Fling or Spree. The cost of the trip is **TOTALLY NON-REFUNDABLE** unless canceled by Gulf Diving, LLC or Scubaland prior to the trip departure. If you must cancel for any reason, please contact Scubaland as soon as possible.

Important Information

1. Please allow sufficient drive time to Freeport. (Approx. 4-5 hours from Austin)
2. You may board the boat no earlier than 8:30 PM the night of departure. The dates we advertise are the actual dive dates. **You will board the boat the night before.**
3. A mandatory orientation will be given at 9:00PM. The boat will depart shortly thereafter. You should be at the dock and ready to board by 8:00 PM.
4. All divers **MUST** bring their **LOG BOOK** and **CERTIFICATION CARD**. Nitrox divers must provide a Nitrox certification card or be with a Nitrox instructor.
5. Sunblock, hat, sunglasses and motion sickness medication are recommended. Losses of dives due to seasickness or weather conditions **DOES NOT** warrant a refund.
6. All divers **MUST** provide the following equipment
 - a. One **FULL** tank, Regulator with Octopus, Pressure and Depth Gauge, Bottom Timer or Underwater Watch, BCD with Low Pressure Inflator, Mask and Snorkel, Booties and Fins, Weight Belt and Weights, Surface signaling device ("See Me"). If you plan to do the night dive, primary and backup lights and a glow stick are **REQUIRED**.
 - b. For safety purposes, a SEA ME safety sausage is **REQUIRED**. A DIVE ALERT power whistle is highly recommended.
 - c. A dive computer is **HIGHLY RECOMMENDED**. Only one person per computer – **NO SHARING**.
 - d. Be sure that you have proper thermal protection.
7. The boat should return to the dock around 7:00pm on the last day.
8. The weather in the Gulf of Mexico is very unpredictable. The decision to depart is made by the captain of the M/V Fling or Spree on the day of departure.
9. Each diver needs to call Scubaland at 512-891-6054 on the day of departure, after Noon to check on the status of the boat.
10. Space is limited on a live-aboard dive boat, so please do not bring an ice chest or soft drinks on the boat. The M/V Fling or Spree will provide a continental breakfast, hot breakfast, lunch, dinner, in-between-meal snacks, coffee and lemonade. Soft drinks and beer may be purchased from the galley.
11. The crew of the M/V Fling and Spree are all volunteers (except the captain) and they work very hard for you. **TIPS** are greatly appreciated.
12. Enriched Air Nitrox is available an extra charge. (Call for details and cost)
